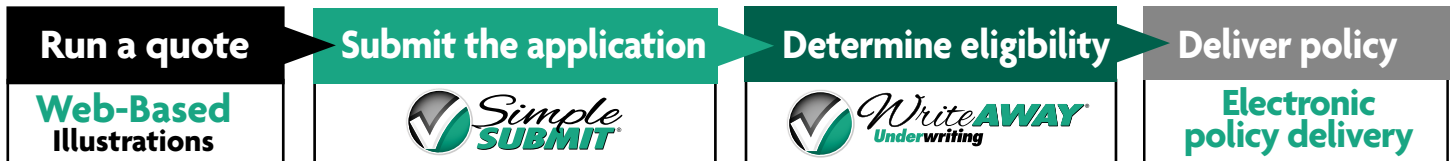

How do these features work together?

The four facets integrate seamlessly to help speed up your life insurance business. Web-Based Illustrations quotes link directly to the SimpleSubmit eApp, which then will guide you through a set of personal health and history questions to determine if your client is eligible for WriteAway. Web-Based Illustrations and SimpleSubmit can also be used separately. Although paper applications will be accepted, SimpleSubmit is the preferred method for submitting applications to qualify for the WriteAway process. Please note, paper applications in California are not eligible for the WriteAway process.
